1 RULES

1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*

1.2 The Yachting New Zealand Safety Regulations Part 1 shall apply.

1.3 Appendix T, Arbitration, will apply.

2 ADVERTISING

2.1 Boats may be required to display advertising chosen and supplied by the organising authority.

3 ELIGIBILITY AND ENTRY

- 3.1** The regatta is open to all boats of the Flying Fifteen Class that comply with the class rules and whose owner(s) are current financial members of their National Class Association
- 3.2** Entries can be made online at www.rayc.co.nz/flying15. Completed entries and fully paid entry fees must be received by 1 February 2019
- 3.3** Late entries, accompanied by the contest entry fee plus the late entry fee may be accepted at the race committee's discretion until 1800 hours on February 6 2019.
- 3.4** To be eligible to compete in this event each entrant and crew member shall be a financial member of a club recognised by the entrant and crew member's national authority.

Proof of affiliated club membership to be presented at registration

4 FEES

- 4.1** Required fees are as follows:
- 4.2** \$150.00 per boat
Late Entry Fee (additional): \$40.00
- 4.3** Other fees: Non-members of the Royal Akarana Yacht Club are required to pay \$20 per boat for storage from February 5 to February 9, 2019.

5 QUALIFYING EVENT

This regatta is the qualifying event for New Zealand representation at the Flying Fifteen World Championships 2019. Places on the team will be determined by their finishing place in the overall regatta

6.6 The scheduled time of the warning signal for the first race each day is 1000.

6.7 On the last scheduled day of racing no warning signal will be made after 1630.

7 MEASUREMENT

7.1 Each boat shall produce a valid measurement certificate.

7.2 Boats may be weighed, and other measurements and inspections may be undertaken to ensure boats meet class rules and safety regulations. Any sails not previously signed will be measured.

8 SAILING INSTRUCTIONS

The sailing instructions will be available after 1200 on 1 February 2019 at www.rayc.co.nz/flying15

9 VENUE

9.1 Attachment A shows the location of the regatta venue.

9.2 Attachment B shows the location of the racing areas.

10 THE COURSES

The courses to be sailed may be any combinations of Trapezoid, Triangle/Windward/Leeward and/or Windward/Leeward legs.

11 SCORING

11.1 5 races are required to be completed to constitute a series.

11.2

- a) When fewer than 6 races have been completed, a boat's series score will be the total of her race scores.
- b) When 6 to 9 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

12 SUPPORT BOATS

Team support boats will be allowed. Support boats must be registered with the Organising Authority at registration [DP]

13 BERTHING

Boats shall be kept in their assigned places while they are in the boat park [DP]

14 RADIO COMMUNICATION

Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats. This restriction also applies to mobile telephones. [DP]

15.1 The Race Channel will be 27 unless the Race Officer advises otherwise

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organising authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

18 RIGHTS TO USE NAME AND LIKENESS

By participating in the event, a competitor automatically grants to the Organising Authority and the sponsors of the event, the right in perpetuity, to make, use and show, from time to time and at the discretion, any motion pictures, still pictures and live, taped or film television and other reproductions of him/her during the period of the competition for said event in which the competitor participated and in all material related to the said event without compensation.
