## NOTICE OF RACE

## 1. RULES

- 1.1 The race will be governed by the rules as defined in *The Racing Rules of Sailing*, and the current Regional Bylaws.
- 1.2 The series will be governed by:
  - 1.2.1 The rules as they apply to IRC and PHRF handicapping methods
  - 1.2.2 This Notice of Race (if there is conflict between documents the Sailing Instructions shall take priority)
  - 1.2.3 The Sailing Instructions
- 1.3 The YNZ Safety Regulations Part 2, Category 3 plus the following will apply:
  - 1.3.1 30% of crew (rounded up) or 2 people whichever is higher, must have current Advanced Sea Survival training
- 1.4 All yachts must carry the following additional equipment extra to Category 3:
  - 1.4.1 Danbuoy and light that meets the YNZ Safety Regulations Part 2, Category 2, rule 17.13 (b) and (c).
  - 1.4.2 Liferaft in service that meets the YNZ Safety Regulations Part 2, Category 3, rule 17.11
- 1.5 The Racing Rules will be modified in accordance with rule 86 as follows
  - 1.5.1 Rules of RRS Part 2 will be replaced during the race between the hours of official sunset and sunrise by the right-of-way rules of the International Regulations for the Prevention of Collisions at Sea.
  - 1.5.2 RRS 52, Manual Power, shall not apply
  - 1.5.3 RRS 63.1 will be altered to allow a penalty to be applied without a hearing to boats failing to meet reporting procedures.
- 1.6 Each competing boat is required to use the PredictWind GPS tracking service as per NOR 19.
- 1.7 **Outside Assistance (Changes RRS 41(c))**
  - 1.7.1 Prior to the preparatory signal, boats may utilize weather information from any source
  - 1.7.2 Whilst racing, no boat shall receive any private communication from paid weather routers or meteorologist or other individuals to provide them with advice, custom data or compilations of public data during the race, not available to all competitors
  - 1.7.3 Boats may receive regularly scheduled weather broadcasts, electronic weather data such as Grib files or other internet based forecast information

including weather routing functions within an application, whether subscription based or free of charge (e.g. Metservice, PredictWind)

## **2. ADVERTISING**

Boats may be required to display advertising chosen and supplied by the Organising Authority.

## **3. ELIGIBILITY AND ENTRY**

- 3.1 The race is open to all monohulls 8m and over and multihulls 8.5m and over which comply with Clause 1 of the Notice of Race.
- 3.2 To be eligible to compete in this event each entrant and crew member shall be a financial member of a club recognized by the entrant and crew member's national authority.
- 3.3 Boats shall hold current safety and handicap certificates as applicable.
- 3.4 To be eligible in the Short- Handed Division, a boat shall only have two (2) crew members on board.
- 3.5 Eligible boats may enter the race by completing the online registration form by midnight Wednesday 15 November 2023 [www.rayc.co.nz/bop380](http://www.rayc.co.nz/bop380)
- 3.6 For an entry to be valid a copy of the boats current rating certificate(s) must be included with their entry.
- 3.7 The Organising Authority reserves the right to refuse, without explanation, any entry.
- 3.8 Late entries will be accepted at the Race Committees discretion and will incur a late fee.
- 3.9 Random safety checks may be made by the Organising Authority

## **4. FEES AND DOCUMENTATION TO BE LODGED**

- 4.1 The entry fee is \$250 per boat.
- 4.2 If the owner/charterer of a boat is a member of RAYC they will receive a rebate of \$50 on the entry fee.
- 4.3 Late entry surcharge \$100 per boat.
- 4.4 Competitors may be required to produce additional documentation following receipt of their entry and will be given a reasonable amount of time to produce this.
- 4.5 For publicity purposes, each boat is required to provide an image of their boat when entering.

**6. SAILING INSTRUCTIONS**

The Sailing Instructions will be available one week prior to the race starting.

**7. CHARTS**

The following charts (in paper form) shall be carried on board: NZ 52, NZ 522, NZ 532 NZ 54, NZ 541 and NZ 5423. In addition, the following chart is recommended: NZ 531

**8. THE COURSES**

**Course 1** - Start at Orakei, leaving, Whale Island (Moutohora) to port, Volkner Rocks (Te Paepae o Aotea) to port, Burgess Island (Pokohinu) to port, Finishing at Orakei  
**Course 2** – - Start at Orakei, leaving Burgess Island (Pokohinu) to starboard, Volkner Rocks (Te Paepae o Aotea) to starboard, Whale Island (Moutohora) to starboard, Finishing at Orakei.

The course to be sailed will be advised by the committee boat prior to the warning signal by displaying the appropriate numeral pennant.

**9. PENALTY SYSTEM**

A boat which, after the warning signal, crosses the start line and fails to return to the pre-start side of the line will be penalized 20 minutes on elapsed time. This changes rules 29 and A4.2.

**10. SCORING**

The following handicap systems will apply:

IRC

PHRF TCF Passage

Multihull – handicaps assigned by NZMYC

A minimum of three boats required to constitute a division

**11. REPORTING PROCEDURES**

Reporting requirements will be outlined in the Sailing Instructions.

**12. PRIZES**

The overall winner will be the winner using PHRF Passage TCF.

Prizes will be determined by the number of entries received and will be outlined in the Sailing Instructions.

**13. CREW SUBSTITUTIONS**

A written request must be provided if crew substitutions are required after entries close. The request must name the crew being replaced, and the new crew's full details and experience. The Race Committee must approve the change.

**14. RESPONSIBILITIES**

It is the responsibility of the owner and/or skipper to see that their boat complied with the requirements of the race, in that its safety category requirements and rating certificates are current, and that the crew contains a nucleus of ocean-experienced member who have sailed before on the yacht. The RAYC Sailing Committee reserves the right to decide the eligibility of any entrant on the basis of the experience of the skipper, navigator and crew. All those taking part do so at their own risk and responsibility. RAYC and the sponsors are not responsible for the seaworthiness of a boat whose entry is accepted or its equipment or its crew and have no liability for any damage, loss or penalty suffered by a boat or a person taking part in this event.

**15. INSURANCE**

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of 5,000,000 per incident or the equivalent.

**16. DISCLAIMER OF LIABILITY**

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organising authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

**17. RIGHTS TO USE NAME AND LIKENESS**

By participating in the event, a competitor automatically grants to the Organising Authority and the sponsors of the event, the right in perpetuity, to make, use and show, from time to time and at their discretion, any motion pictures, still pictures and live, taped or film television and other reproductions of him/her during the period of the competition for said event in which the competitor participated and in all material related to the said event without compensation.

**18. USE OF DRONE FOR MEDIA**

All those who take part in the race as competitors as well as support crew or spectators agree to be overflown by a drone during the duration of the event, this includes your person and your property (boats).

**19. PREDICTWIND TRACKER**

19.1 For safety reasons, increased interest in online viewing of the race and developing race organisation practice, each entrant is required to use the PredictWind GPS tracking service. To use the service, you will need two smartphones (one as a back-up) that use either iOS9 and above or Android 6.0 and above operating system. The PredictWind GPS tracking service is being made available at no cost to each competitor.

19.2 Full instructions on how to install and use the app are found at <http://www.predictwind.com/tracker>; Select yacht club: RAYC; Race: 2023 BoP 380 Select your division and manually enter your yacht name. It is recommended that all competitors test the tracking functionality at least one month before the event and view the data at <http://forecast.predictwind.com/tracking/race/rayc> to ensure that the service is working on their phone. 19.3 It is the crews' responsibility to test that the system works on their phones prior to the race. Each competitor is expected to check their tracker is turned on and check battery levels are satisfactory at the start and each radio schedule. Only one phone should be used to send tracking data at any time. Failure to use the tracker for the entire race may result in a 1-hour time penalty for the yacht not sending the tracking data. [DP]
