The notation '[DP]' in a rule in the NOR means that the penalty for a breach of that rule may, at the discretion of the protest committee, be less than disqualification.

1. Rules

- 1.1. The regatta will be governed by the rules as defined in the *Racing Rules of Sailing*.
- 1.2. The Yachting New Zealand Safety Regulations Part 1 shall apply.
- 1.3. The Sailing Instructions, and supplementary sailing instructions in RRS Appendix S, Standard Sailing Instructions, and supplementary sailing instructions that will be on the official notice board located on the right in the Club Boat Storage Facility.
- 1.4. RRS Appendix T, Arbitration, will apply.
- 1.5. Measurement Checks to check compliance with NOR 1.7 and the YNZ Safety Regulations may be carried out at any time during the regatta at the discretion of the Race Committee.
- 1.6. There will be no restrictions on substituted equipment provided measurement is in accordance with 1.7
- 1.7. 12FT Skiff Class Rules shall apply.

2. Eligibility

- 2.1. The regatta is open to 12FT Skiffs complying with current class measurement.
- 2.2. All entries are to be received via the online form at <https://rayc.co.nz/12footskiff/>
- 2.3. Boats intending on racing must enter by no later than Thursday 4 January
- 2.4. The Entry Fee is payable on registration.
- 2.5. Skippers & Crew are required to be financial members of a club recognised by the sailors members national authority.
- 2.6. The Organising Authority Reserves the right to refuse, without explanation, any entry received.

3. Sailing Instructions

- 3.1. The Sailing instructions will be available at the race briefing and via the website <https://rayc.co.nz/12footskiff/>

4. Advertising

- 4.1. The Organising Authority may require all participating boats to display event sponsors advertising. If this rule is broken, World Sailing Regulation 20.9.2 applies. [DP]
- 4.2. A boat may carry advertising on her hull and sails with no restriction

5. Entry Fee

- 5.1. The Entry Fee is \$80.00
- 5.2. Entry is required for results to be recorded and published.
- 5.3. Late entries will be accepted at the discretion of the Organising Authority.
- 5.4. Entries close 28th December at 5pm

6. Schedule

Thursday 28 December	17:00 - Entries Close
Thursday 4 January	10:00 – Briefing 11:00 – Race 1 14:00 – Race 2 & 3
Friday 5 January	11:00 – Race 4 14:00 – Race 5 & 6

7. Venue

- 7.1. The host club is Royal Akarana Yacht Club.
- 7.2. The racing area will be the inner Waitemata Harbour, in an area approximately described as stretching from Rough Rock, Bean Rock, St Heliers Beach & Mechanics Bay.

8. Courses

- 8.1. The courses will be harbour courses outlined in the Sailing Instructions.

9. Penalty System

- 9.1. Rule 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

10. Scoring

- 10.1. 6 Races are scheduled with no reserve day.
- 10.2. 4 Races are required to be completed to constitute a series.
- 10.3. There will be one (1) drop for every 3 races completed.

11. Support Boats

- 11.1. Support boats shall be registered prior to 48 hours before the first briefing for the event.

12. Radio Communications

- 12.1. Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction includes mobile telephones. [DP]
- 12.2. The Race Channel will be 77 unless the Race Officer advises otherwise.

13. Disclaimer of Liability

- 13.1. Competitors participate in the regatta entirely at their own risk. See Rule 4 (Decision to Race). The Organising Authority will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.

14. Rights to Use Name & Likeness

- 14.1. By participating in the event, a competitor automatically grants to the Organising Authority and the sponsors of the event, the right in perpetuity, to make, use and show, from time to

time and at the discretion, any motion pictures, still pictures and live, taped or film television and other reproductions of the competitor during the period of the competition for said event in which the competitor participated and in all material related to the said event without compensation.

15. Use of Drone for Media

15.1. All those who take part in the regatta as competitors as well as support crew or spectators agree to be overflown by a drone during the duration of the event, this includes your person and your property (boats).

16. Insurance

16.1. Each participating boat shall be insurance with valid third-party liability insurance with a minimum cover of NZD \$3,000,000 per incident or the equivalent.
